 2. The Qardan Hasana application form will be sanctioned against Gold & / or guarantors signature.
 3. Valuation to be done by Committee Approved Government Valuer.
 4. The guarantee of the following will not be accepted
1) Family Members 2) Trustees 3) If Guarantors for more than two Applicants.
 5. The Trustees have all the rights to accept or reject the application form of Qardan Hasana. The sanctioning of Qardan Hasana shall be decided on merit available of funds and as per the decision of the Trustees. The decision is binding on the applicant without any further question.
